Other team apparel is also purchased for the boys which costs go over what we are given per player. We are purchasing jackets for each player this year which cost \$80/each. And with socks, training gear and other items we will need the fundraising funds to offset the cost. Travel to St. George is offset by this fundraiser as well. Total cost this year is 11,000 for 3 days, and the boys will cover \$7000 of that. The other \$4000 will come from fundraisers. And this is an annual trip.


Describe the fundraising activity(ies), including how the money will be collected and accounted for, and identify whether activity is a team/group/organization or individual student fundraising activity.

Due to Covid-19, all fundraising will be done online this year. Players will be asked to send out emails with a link to the site which will ask for donations to our program and allow them to purchase the meal deal cards on the site using debit or credit cards. The only face to face will be when the boys deliver the cards to those who purchased.

Only transportation required will be personal for when boys deliver purchased items. They will be asked to wear masks and respect social distancing while in this activity. I dont see any potential risks.



- For individual student fundraisers, students must be given the opportunity to directly pay the costs that are assessed to them instead of fundraising.
- Students may not be assessed fees in excess of the Board approved fee schedule.
- The parents/guardians of elementary students must give permission for their students to participate.
- Raffles are illegal in Utah and are, therefore, prohibited as a fundraising effort.
- Door-to-door sales are prohibited.
- Potential risk concerns, including student safety, transportation issues, and appropriate supervision.
